Your child, through attendance at this mandatory tryout, is a candidate for the 12U Warren Travel Baseball team. The team may play in a League as well as in a number of tournaments, the Cal Ripken NJ District Tournament and at Cal Ripken Tournament, Myrtle Beach, South Carolina.

- ❖ There is no "MUST PLAY RULE" in Travel.
- ❖ All playing time and position assignments are solely within the discretion of the coaching staff.
- ❖ Parents are not allowed on the fields or in the dugouts at any time during games or practices, unless otherwise requested by the coaches.

Travel teams require an absolute commitment from each player and each parent. The exclusive and primary obligation of each player selected to a Travel team is to that team. All players are expected to attend all games and practices, and remain at all games and practices until completion. Travel teams are a time consuming program. If you and your child are not willing to make this type of commitment then your child should not try out for a team. No second teams will be created until after a first team has fully been selected.

Selection of the players on each Travel team will be made by WBSI and/or at their discretion qualified paid evaluators and the appointed coach. Selection to a Travel team is a privilege, not a right, and the decision is within the complete discretion of WBSI.

In order to be a candidate for an Travel team, the candidate and parents/guardians hereby understand and agree to waive any and all legal rights to bring any legal action in any Court of Law against the WBSI, its Officers, Directors, Board Members, Members, Coaches, and Assistant Coaches arising out of, but not limited to, the selection process, ultimate selection of any player for any team and all coaching staff decisions. It is also understood and agreed, that in order to be a candidate for a Travel team that the candidate and parents/guardian agree to defend, indemnify and hold the WBSI, its Officers, Directors, Board Members, Members, Coaches, and Assistant Coaches harmless for any claim made arising out of the Travel selection process, ultimate selection, coaching decisions and any and all activities of the WBSI Travel program. The Travel coaches have been nominated by the Travel Team Commissioner of the WBSI and approved by the WBSI Board of Directors.
